Dear Judge Coughlan,

The City of Ripon welcomes the opportunity to respond to the 2022-2023 San Joaquin Grand Jury Case #0322 Report regarding School Safety: A Shared Responsibility. The City of Ripon always welcomes independent review of security measures and safety plans of the school sites within our community, and thanks the Grand Jury for its efforts.

The City of Ripon has reviewed the report provided and implemented many of the recommendations. The City of Ripon would also like to take the opportunity to address the Report's findings and recommendations. Our comments follow below.

## **Grand Jury Findings:**

Many district CSSPs show a lack of meaningful collaboration between districts and local F2.4 law enforcement agencies, causing confusion and chaos during an emergency.

The Ripon Police Department has long enjoyed a mutually beneficial relationship with the Ripon Unified School District, working collaboratively on a variety of issues and ongoing challenges. The partnership includes administrative and school site security evaluations, suggestions, and discussion, along with input and planning into the Ripon Unified School District and the individual school sites CSSPs, culminating in staff development training between the entities and practical training exercises.

Finding F2.4 does not specifically reference the Ripon Unified School District or the City of Ripon when discussing the perceived lack of inter-district collaboration. Fortunately, Finding F2.4 does not apply to Ripon Unified School District and the City of Ripon. The Ripon Police Department reaffirms the importance of ongoing meaningful collaboration with the Ripon Unified School District in the preparation and updating of the Comprehensive School Safety Plan, which has been on-going between the two entities.

## **Grand Jury Recommendations:**

In responding to the Grand Jury's recommendations, we note each recommendation and the City of Ripon's response follows.

R2.4 By December 15, 2023, each law enforcement agency in San Joaquin County meaningful ly collaborate and approve the updated CSSP for school sites within that agency's jurisdiction.

The City of Ripon Police Department and other governmental agencies within our jurisdiction began collaborating with the Ripon Unified School District in September of 2022 to update the current CSSPs. The City of Ripon Police Department will continue to work with the Ripon Unified School District and other involved agencies to update and approve the CSSP.

The City of Ripon would like to once again thank the Grand Jury for its effort in their review of the City's security posture
