of the San Joaquin County Chapter of the California Grand Jurors' Association.

Members of the Civil Grand Jury serve for a one year period beginning July 1, 2015. The Grand Jury is comprised of nineteen citizens whose names are randomly selected from applicants

nominated by the Judges of the Superior Court. The Civil Grand Jury inquiries into and investigates the functions and operations of governmental bodies, agencies and public officials within San Joaquin County, as well as investigates formal complaints received from the public. Past reports have focused on juvenile group homes, community college and school districts, jail operations, special districts and housing authorities.

Former grand jury members have found their participation on the Grand Jury a positive and worthwhile experience.

"The year I spent on the 2012-2013 San Joaquin Civil Grand Jury was one of the most rich and rewarding experiences I have had in my life. As foreperson, I had the fortune of amazingly talented and dedicated members who worked as a team for great results. We learned, explored, investigated and of course wrote recommendations of significance for the improvement of government in our County," said Gary Spaugh, Former Grand Jury Foreperson and semi-retired healthcare administrator.

"The privilege of serving on the 2013-2014 Grand Jury gave each juror the experience of working intensely with many new friends. We learned a whole lot about this interesting County, and at the same time we were able to make life a little better for many of its people," said Ward Downs, retired educator and foreman of the current Grand Jury.

A Grand Juror must be at least 18 years of age, a United States citizen who has resided in San Joaquin County for at least one year, possess sufficient knowledge of the English language, and is not now serving as a trial juror or elected public official. Qualified applicants may be interviewed by a Superior Court Judge. The San Joaquin County District Attorney's Office will conduct background investigations, which includes a record check from law enforcement agencies.
