## SAN JOAQUIN COUNTY COURTS EXPECTS TO REDUCE SERVICES IN LIGHT OF FURTHER BUDGET CUTS

The budget passed in Sacramento this week dealt a crippling blow to the courts. An additional \$150 million was taken from the trial courts and \$300 million from court construction funds in spite of strenuous opposition by court leaders.

Last week, Judicial Branch leaders issued a letter to Governor Jerry Brown, Senators, and Assembly Members to make known their "strong and unified opposition to any further legislative efforts to direct additional budget reductions to California's 58 trial courts." The letter was signed by six administrative presiding justices of the California Courts of Appeal, along with the presiding judges and court executive officers of all 58 trial courts in the state.

The letter came after both houses of the legislature passed a budget that called for an additional \$150 million cut from the trial courts. The letter states that "this is the third consecutive year of crippling budget reductions to the judicial branch...the proposal to take an additional \$150 million cut from the trial courts was and will be unsupportable. The branch represents approximately 2.88% of the state budget, yet the reductions and other budget solutions of \$790 million proposed for this year along represent 3.5% of the State's budget solution. In March, the branch willingly concurred with a \$200 million cut. Several weeks ago the governor vetoed a budget plan which included additional cuts but this week approved a budget which included the additional cuts.

Presiding Judge Robin Appel, who also signed the letter said, "The courts in San Joaquin County have historically been underfunded and under resourced. Further reductions to the courts

will negatively impact our ability to dispense fair and equal justice to the citizens of our county. The bottom line is that the public will be left with an inadequate system of justice to rely on."

With the additional cuts on top of the \$200 million cut already taken for this fiscal year, court leaders forewarn the Governor and legislature of the catastrophic consequences that will follow, including the closure of clerk's offices and courtrooms, public counter and courtroom hours will be reduced, and the possibility that entire caseloads may not be heard as all resources will need to be focused on criminal and juvenile proceedings, which are high priority. The letter declares that "the public will experience longer lines, backlogs in processing filings and judicial orders, and significant encroachment on due process rights of defendants as interpreters become less available and other courtroom support services are sharply diminished. These are but a few known impacts to the public if additional cuts are made to the judiciary."

Specifically in San Joaquin County, the presiding judge warns that court will not be able to maintain the level of service it has provided to the public. Changes as a result of further funding reductions are anticipated to include the closing of the entire Tracy court branch of the courts, the elimination of one of the Lodi courts leaving the remaining court open to handle only in-custody criminal matters, the elimination of certain case types including small claims hearings, fish and game hearings, and possibly civil cases. The clerk's office hours were reduced last year as a result of budget cuts and even shorter hours for public access is anticipated. Judge Appel stated "It is almost incomprehensible that an entire branch of government is being forced to eliminate the basic fundamental right of people to have access to the courts to address their grievances". She urges the public to contact their local legislators to voice their strong opposition to the draconian cuts to the judicial branch of government and in particular to the severely underfunded courts in San Joaquin County.

Re: Judicial Branch Budget

Dear Governor Brown, Senators, and Assembly Members:

We write to express our strong and unified opposition to any further legislative efforts to direct additional budget reductions to California's 58 trial courts. The impact of this action would be nothing short of catastrophic to the administration of justice and the public we serve. Chief Justice Tani Cantil-Sakauye eloquently stated our shared belief, in response to the proposed \$150 million additional budget reduction included in AB 98, that "[w]ith these cuts courts cannot provide . . . fundamental services or protect the rights of Californians. By marginalizing the courts, California strikes a blow against justice". The impact of any additional reductions will affect the civil rights of every Californian and render precarious our democratic ideal of justice for all.

This is the <u>third</u> consecutive year of crippling budget reductions to the judicial branch. The branch has experienced devastating budget reductions for two prior fiscal years, resulting in a permanent decrease in baseline funding of \$297 million, before this budget year even began. In the proposed budget put forward in January, and the budget approved by the Legislature in March, you asked the branch to take an additional unallocated \$200 million cut, loan the State General Fund \$350 million from our State Court Facilities Construction Fund, and loan the State General Fund \$90 million from our Immediate and Critical Needs Account. The branch willingly concurred with your proposals. The proposal to take an additional \$150 million cut from the trial courts was and will be unsupportable. The branch represents approximately 2.88% of the state budget, yet the reductions and other budget solutions of \$790 million proposed for this year alone represent 3.5% of the State's budget solution. By adding this cut to the reductions imposed on the judiciary since fiscal year 2009-2010, the judicial branch will have absorbed a cumulative reduction of more than 30% in General Fund support.

A further budget reduction of this magnitude will have a devastating impact on the public. Since courts have no statutory authority to close their doors, as the Executive Branch has

done, the effects on public service will be difficult to countenance each and every day. Unlike higher education, trial courts do not control the number of users of the justice system and cannot independently raise user fees, such as admissions, or engage in fundraising to mitigate budget reductions. The adage, 'justice delayed is justice denied' will be a predictable and inevitable result of these reductions. The public relies on California courts when they are most vulnerable. They rely on the courts to protect their most basic human needs. They rely on the courts to protect them from harm, reunify them with their children, and ensure that they have a forum to resolve business disputes, enforce contracts, and preserve and protect their housing.

Any additional reduction, on top of the cuts already made for this budget year and the cuts courts have 'operationalized' from prior years, will mean that Californians will not be well served by their justice system. The public may find the clerk's office closed or courtrooms not in session, as public counter and courtroom hours will be reduced. Conceivably, even entire caseloads may be unserved, as courts may be required to dedicate all available resources to the highest priority filings, like criminal and juvenile proceedings. Victims of domestic violence may not receive protective orders in a timely manner. Self-help services may be severely curtailed for those needing assistance with child support, custody and visitation matters, housing —related issues, or conservatorships to protect elders and dependent adults. The public will experience longer lines, backlogs in the processing of filings and judicial orders, and significant encroachment on due process rights of defendants as interpreters become less available and other courtroom support services are sharply diminished. These are but a few of the known impacts to the public if additional cuts are made to the judiciary.

Below are the names of key leaders of California's judicial branch, including the 6 administrative presiding justices of the California Courts of Appeal, and 58 presiding judges and 58 court executive officers from California's trial courts, joining together in support of statements made by Chief Justice Tani Cantil-Sakauye to let you know that further reductions to the courts will adversely affect the people in all of our communities throughout the state. Moreover, the judiciary will be severely compromised in executing its core mission and responsibilities, if this catastrophic budget action is not reversed. Please do not allow this budget crisis to marginalize the third branch of government and one of the cornerstones of our democracy, a strong and effective judiciary. We urge you not to impose further reductions on the judicial branch. We respectfully thank you for your thoughtful consideration of this urgent request.
