GENERAL ORDER: COUNTY-WIDE EMERGENCY ORDER RE  
TEMPORARY MODIFICATION TO MISDEMEANOR BAIL SCHEDULE  
HONORABLE XAPURI B. VILLAPUDUA, PRESIDING JUDGE

APRIL 1, 2020

EFFECTIVE IMMEDIATELY

In an order issued March 30, 2020, the Honorable Tani G. Cantil-Sakauye, Chief Justice of California (Chief Justice), indicated that the World Health Organization, the United States Centers for Disease Control and Prevention (CDC) and the State of California have recognized that the world, country, and state are facing a life threatening pandemic caused by the 2019 novel coronavirus (COVID-19). She further stated that pursuant to and in accordance with executive orders that had been issued by California Governor Gavin Newsom, on March 20, 2020, she had previously issued advisory recommendations to California's superior courts, which were aimed at protecting the constitutional and due process rights and the health of judges, court staff, and court users, and was authorizing the implementation of her advisory recommendations. The advisory recommendations included adopting local rules and revising, on an emergency basis, county-wide bail schedules for in-custody defendants to address the impact of COVID-19, to take effect immediately and without advance circulation for public comment.

Pursuant to and consistent with the Chief Justice's Emergency Order of March 30, 2020, the 2019-2020 Uniform Bail Schedule adopted by the Judges of San Joaquin County Superior Court, effective December 1, 2019, is hereby temporarily modified, effective immediately, to reflect the following bail amounts for misdemeanor offenses:



Consistent with the Chief Justice’s Emergency Order of March 30, 2020, the above modifications are being imposed temporarily to address the current COVID-19 crisis, and I reserve the authority to rescind or modify this Order as appropriate to address the changing circumstances. In addition, this Order shall be deemed a part of the record in affected cases for purposes of appeal, without the need to file the Order in each case.
