Clinic staff will discuss the issues you need help with, help you to understand the court system, and provide instructions on completing the necessary forms. You must bring a copy of all court documents relating to your case organized by date. Do not bring children to the Clinic. Often times the issues that will be discussed are not appropriate for children to hear. Please note that the Pro Per Clinic does not provide legal advice and will not represent you in court. The Clinic is available to both parties.
